Extension and Expansion of the Use of 'Carbon-Free Clean Electricity' at Open House Arena Ota -Gunma Crane Thunders Decarbonization Project -

The Group's professional basketball team, Gunma Crane Thunders, will continue to use "carbonfree clean electricity" for the games held at Open House Arena Ota for the 2023-24 season, starting from the match on April 6, 2024 (Saturday). We are pleased to inform you as follows.

1. Our Journey Towards Decarbonization So Far

The Group is committed to promoting "sustainability" and aims to achieve a sustainable society and the continuous growth of the company. In particular, we recognize that addressing climate change is an urgent issue.

In November 2021, in line with the disclosure of information based on the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD), we set medium to long-term goals for reducing GHG (greenhouse gas) emissions. Additionally, starting October 2022, we introduced a "CO2-free menu" for the customers who purchased the Group's single-family homes, which effectively makes the CO2 emissions from their electricity use zero. We have also started a solar power generation business towards creating electricity derived from renewable energy, as part of our efforts to decarbonize.

2. Expansion of "Carbon-Free Clean Electricity" Supply to the Entire Ota City Sports Park

From October 2023 to March 2024, we were able to use "carbon-free clean electricity" exclusively at Open House Arena Ota. However, from April 2024 to March 2025, V-Power Corporation has expanded the supply area to cover the entire Ota City Sports Park, making clean energy accessible to everyone in the park.

With this new initiative, we hope to spark interest in clean energy among the local community and pave the way towards a sustainable future. The Group will continue to intensify the efforts towards promoting clean energy and reducing carbon dioxide emissions, thereby continuing to contribute to the global environment.

Ota City Sports Park

Ota City Sports Park is a comprehensive sports facility operated by Ota City, which aims to be a "city expanding through sports". The park spans a vast area of 16.5 hectares and is equipped with numerous sports facilities such as an athletics stadium, a baseball field, and soccer/rugby fields, making it a frequent gathering place for residents.

In one corner of the park, the Ota City General Gymnasium (nicknamed: OPEN HOUSE ARENA OTA) was completed in April 2023. It is utilized as the home arena for the Gunma Crane Thunders. The facility aims to serve as the core of sustainable community revitalization and become a beloved new facility in Ota City.

4. Gunma Crane Thunders (Belonging to the B1 East Division of the B. LEAGUE)

The Gunma Crane Thunders (operated by Gunma Pro Basketball Commission Co., Ltd.) is a sports team based in Ota City, Gunma Prefecture, with the goal of "energizing the community". We are working in conjunction with the local community, our fans, and partner companies.

Since September 2021, the Gunma Crane Thunders have been carrying out a social contribution activity called "CRANE THUNDERS ONGAESHI", under the principle of "Off-Court 3P". This represents Planet (protection of the global environment), People (assistance to those in need), and Peace (building a community where people can live in peace).

In May 2022, as part of our efforts to address climate change and global environment, we signed the "UN Sports for Climate Action Framework". This initiative is promoted by the United Nations Framework Convention on Climate Change (UNFCCC) and the International Olympic Committee (IOC), and has been signed by global sports organizations and teams, such as the International Basketball Federation (FIBA), the International Federation of Association Football (FIFA), the Golden State Warriors of the NBA, and the New York Yankees of the MLB.
