4. Comments from Board Members

(1) Comments from Mr. Masaaki Arai, President and Representative Director

Founded in 1997, the Company has expanded its group business domain through aggressive M&A in real estate-related fields. In 2013, we were listed on the First Section of the Tokyo Stock Exchange (currently the Prime Market) and since then we have continued to increase revenues and profits, achieving sales of over 1 trillion yen in the fiscal year ending September 30, 2023. We are proud to say that we have grown to become one of leading comprehensive real estate groups in Japan.

Over this time, while delegating authority as appropriate, I have been developing the next generation of our management and in order for the group to further progress, I believe it necessary for management executives other than myself to be able to assume a level of leadership one or two ranks higher.
